- 3. Students belonging to UR/EWS/OBC-NC category should have secured minimum 60% (aggregate marks upto last semester) in qualifying degree (B.Tech/BE), relaxed to 50% (aggregate marks upto last semester) for SC/ST/PWD candidates
- 4. Students with drop in academic year or live ATKTs or backlogs as on date of application are not eligible
- 5. Age: Maximum 25 years as on 30.06.2024 for the UR/EWS category candidates i.e. candidates born on or after 30.06.1999. Maximum age limit is relaxed by 5 years for SC & ST, 3 years for OBC-NC and 10 years for PWD (UR), 13 years for PWD (OBC-NC) and 15 years for PWD (SC/ST) candidates, as applicable

(Res.) dated 30-05-2014 from a competent authority issued in the year of advertisement. Further the OBC-NC candidates will have to give a self-undertaking, at the time of GT/PI if called for, indicating that they belong to OBC-Non Creamy Layer
