INFORMATION ON ONLINE REPORTING AND ADMISSIONS

Dear Sir/Madam,

The first three regular rounds of DASA-2020 would be completed on 17th November 2020. The list of applicants, who are allotted specific Institutions/ branches as per the allotment list and from whom the acceptance of the seat allotment has been received within the specified time frame, will be forwarded to the concerned Participating Institute (PI) for granting the provisional admission. The reporting and admission at the allotted Institute is scheduled during Nov 17-19, 2020.

All the PIs for DASA-2020 are hereby informed that most of the candidates being admitted under DASA -2020 reside outside India and it may be difficult for them to be physically present at the allotted Institute for reporting and admission during the specified dates of Nov 17-19, 2020 after the third round of allotment as per the DASA-2020 schedule due to the non-availability of regular flights and quarantine norms arising out of COVID-19 pandemic situation. In view of this, it is hereby informed that the PIs may arrange to conduct the online reporting and admission during Nov 17-19, 2020. The DASA-2020 portal will be available to the PIs for online reporting at the Institute after the third round. However, the Institutes are requested to make arrangements for the online admission.

Individual PIs should display on their website the details of mode of admission, admission modalities, document requirements, additional fee requirements and other Instructions if any, to the candidates

Fee Structure

The Tuition fee collected by DASA -2020 at NITK for different categories under DASA-2020 admissions is as follows:

FOR CIWG category Rs.62500 For DASA-,NON SAARC \$4000 For DAS-(SAARC) \$ 2000

The semester tuition fee per semester to be paid by DASA -CIWG candidates is fixed at Rs 62,500/- for NITs and IIEST,Shibpur. However, the tuition fee payable by DASA -CIWG candidates being admitted to the Institutes other than NITs and IIEST,Shibpur, may be as prescribed for other Indian National students being admitted to their Institute under Regular mode of admission. Such Institutes may clearly notify their fee structure on the website and inform the candidates about the additional tuition fee to be paid.

All the Participating Institutes are also requested to notify the other fees (excluding tuition fees) to be paid by the candidates at the time of admission.

A few of the candidates have paid lesser than the prescribed amount of tuition fee to DASA-2020, due to the conversion rate issue. A list of such candidates and the balance amount to be paid by them would be communicated to the concerned Participating Institute at a later date. The Participating Institute may kindly collect the same from such candidates.

The participating Institutes are requested to refer the DASA-2020 brochure available at https://dasanit.org/dasa2020/ for details on eligibility and the documents to be submitted at the time of admission.

Please note that as per the Notification, F.No. 37-2/2020-TS.III of, Government of India, Ministry of Education (Shiksha Mantralaya) Department of Higher Education, dated 22nd October, 2020, the academic eligibility for the year, 2020-21 has been revised and is as follows:

Academic Eligibility

Applicant must have passed the qualifying examination, i.e. Senior Secondary [10+2] or equivalent from any system of education as recognized by the Association of Indian Universities (www.aiuweb.org).

AND

Applicant should have completed successfully Mathematics, Physics and one of the subjects from (Chemistry, Bio-technology, Computer Science, Biology) in 11th AND / OR 12th, as applicable in the respective boards.

Applicants appearing for the qualifying examination with the above mentioned subjects in the academic year 2019-20 and expecting their final results latest by November 30, 2020 may also apply.

AND

Applicant should have a minimum total valid score of 1800 in SAT Subject Tests (Subjects: Mathematics Level 2, Physics and Chemistry).

Note: For Architecture, No candidate shall be admitted to architecture course unless she/he has passed 10+2 scheme of examination with physics, chemistry and mathematics or passed 10+3 diploma examination with mathematics as compulsory subject.

Internal sliding

All the participating Institutes are hereby requested to conduct internal sliding on November 21, 2020 on the basis of inter-se merit and choice for internal sliding indicated by the applicant at the time of admission for vacancies that exist in the particular institute on completion of admission process. After the internal sliding is completed, the participating Institutes are requested to notify the vacancy status to DASA Office at NITK Surathkal. DASA-2020 would further conduct the spot round

on November 28, 2020. Those applicants provisionally selected for admission through the Spot round would report for admission in allotted Institutes between November 29 – December 02, 2020.

The Coordinators of DASA-2020 seek the support of all the Participating -Institutes in this regard and hope for the smooth and successful conduct of the entire process of admission under DASA-2020..
