Applications are invited for admission to MBA (Master of Business Administration) Programme offered by the Department of Humanities, Social Sciences and Management, NIT Srinagar for the Academic Session Autumn-2025

Eligibility Criteria for Admission to MBA Degree:

Candidate should be a graduate degree holder under 10+2+3 or 10+2+4 pattern in any discipline, securing at least 60% marks or 6.5 CGPA in aggregate, from a recognized university for OPEN/EWS/OBC and for SC/ST/PWD candidates 55% Marks or 6.0 CGPA. Only primary mode of evaluation (amongst CGPA or percentage) as mentioned in the qualifying degree certificate / marks sheet shall be considered while verifying eligibility.

The selection of the candidates for admission to the MBA programme shall be based on the overall merit obtained by candidate in a two-step process as given at following;

Step I: A valid score of Common Admission Test (CAT) or Common ManagementAdmission Test (CMAT) or Management Aptitude Test (MAT).

Step II: Group Discussion (GD) & Personal Interview (PI).

Selection will be based on the overall merit of the candidates scored in both of the above Step I &Step II.

In case seats remain vacant, the Department shall conduct an Institutional level test followed by Group Discussion & Personal Interview for admission process.

The candidates who do not have a valid CAT / MCAT / MAT can also apply, However it is emphasized that Intuitional level test will only be conducted if seats remain vacant as per the seat matrix.

The Institutional level test shall be conducted on the following lines:

The candidates have to apply online using the https://nitsriadmission.samarth.edu.in. Candidates are required to pay application processing fee of Rs: 1500 (One Thousand and Five Hundred only) for General/OBC-NCL and Rs.750 (Rs SevenHundred and Fifty Only) for SC/ST/EWS/PwD through online mode.

Applications will be screened by concerned Department and list of eligible candidates will be available on Institute website: www.nitsri.ac.in. All announcements related to admissions will be made through our website only. All candidates are advised to keep in touch with the Institute website till the process of enrolment is complete.

The selection will be provisional subject to the verification of the following documents inoriginal and fulfillment of requirements as per the statutes and advertisement.

Documents (As Applicable) to be uploaded along with application:

- 1. Matriculation (DoB) certificate.
- 2. CAT/ CMAT/MAT valid score card.
- 3 Graduation grade/marks card + Degree Certificate/ Provisional Certificate as a single PDF
- 4 Migration certificate.
- 5 Schedule Caste / Schedule Tribe / Physically Handicapped Certificate / OBC (NCL)Certificate / EWS certificate.
- 6 In case of OBC-NCL/GEN-EWS category, the certificate must have been issued on or after April 01, 2025.
- 7 The authorities competent to issue Category/Caste Certificates are indicated below:
- District Magistrate / Additional Magistrate / Collector / Deputy Commissioner / AdditionalDeputy Commissioner / Deputy Collector / First Class Stipendiary Magistrate / Sub-Divisional magistrate / Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner (not below the rank of 1st Class Stipendiary Magistrate), Chief Presidency Magistrate / Additional Chief Presidency Magistrate / Presidency Magistrate, Sub-Divisional Officer of the area where the candidate and / or his family resides, Revenue Officer not below the rank of Tehsildar.
- 9 Candidates whose final year result is yet to be declared are also eligible to apply, however they have to submit their certificate / marks card at the time of enrolmentif selected. They should enter 00 in the Percentage/CGPA field. They should also upload the complete transcript of marks / grade up to last but one semester / year.
