Applications are invited for admission in P.G. Programmes as detailed below for the Academic Session Autumn 2025 under Self Sponsored / Sponsored category / unfilled vacant seats of CCMN-2025:

The Institute level examination will be conducted to fill up the Self Sponsored / Sponsored category and vacant seats after NSR of CCMN-2025; as per the guidelines of the Institute. Reservation seat matrix will be followed for the vacant seats (if any) of CCMN 2025.

*In case all seats of CCMN-2025 are filled, then Institute cannot admit any of the candidate/s having appeared in the above written test under this category.*

**Eligibility:**

The basic eligibility criteria for qualifying degree will be as per CCMN-2025 which is as follows:

In qualifying degree, the candidates should have passed and secured at least 6.5 CGPA (on a 10-point scale) or 60% for GEN/GEN-EWS/OBC, whereas 6.0 CGPA (on a 10-point scale) or 55% in case of SC/ST/PwD candidates. The above mentioned CGPA/ Percentage should be awarded by a recognized University / Institute.

Only primary mode of evaluation (amongst the CGPA or percentage) as mentioned in the qualifying degree certificate/ marks sheet shall be considered while verifying eligibility.

The relevant degrees to be considered for determining the eligibility will be strictly as per the CCMN 2025 Guidelines.

**Pattern of Examination:** The question paper will consist of 60 MCQ type questions of maximum marks 60. Each correct answer will carry 1 (One) mark and for wrong answer, 0.25 mark will be deducted. Questions not attempted will be given zero mark. The duration of exam will be of 90 minutes.

**Application submission:**

The candidates have to apply online using the <https://nitsriadmission.samarth.edu.in>

Candidates are required to pay application processing fee per specialization of Rs.1500 (One Thousand and Five Hundred only) for General/OBC-NCL and Rs.750 (Rs Seven Hundred and Fifty Only) for SC/ST/EWS/PwD through online mode.

Applications will be screened by concerned Departments and list of eligible candidates will be available on Institute website: [www.nitsri.ac.in](http://www.nitsri.ac.in). All announcements related to admissions will be made through our website. All candidates are advised to keep in touch with the Institute website till the process of enrolment is complete.

The selection will be provisional subject to the verification of all the documents in original and fulfillment of requirements as per the statutes and advertisement.

**Documents (As Applicable) to be uploaded along with application:**

1. Matriculation (DoB) certificate.
2. Graduation grade/ marks card + Degree Certificate/ Provisional Certificate as a single PDF
3. Schedule Caste / Schedule Tribe / Physically Handicapped Certificate / OBC (NCL) Certificate/ EWS certificate.
4. In case of OBC-NCL / GEN-EWS category, the certificate must have been issued on

- or after April 01, 2025.
5. The authorities competent to issue Category / Caste Certificates are indicated below:  
District Magistrate/Additional Magistrate/ Collector/Deputy Commissioner/ Additional Deputy Commissioner/ Deputy Collector/ First Class Stipendiary Magistrate / Sub-Divisional magistrate / Taluka Magistrate / Executive Magistrate / Extra Assistant Commissioner (not below the rank of 1<sup>st</sup> Class Stipendiary Magistrate), Chief Presidency Magistrate / Additional Chief Presidency Magistrate / Presidency Magistrate, Sub-Divisional Officer of the area where the candidate and / or his family resides, Revenue Officer not below the rank of Tehsildar.
  6. Candidates whose final year result is yet to be declared are also eligible to apply, however they have to submit their certificate / marks card at the time of enrolment if selected. They should enter 00 in the Percentage/CGPA field. They should also upload the complete transcript of marks/ grade up to last but one semester/year.
