Age

: Not more than 25 years (relaxed to 30 years in case of SC/ST candidates and 28 years in case of OBC (Non Creamy Layer) candidates) as on **01.07.2022**. Upper age limit for Persons with Disabilities (PWD) candidates is relaxable by 10 years. Persons with 40% or more Disabilities shall be eligible for relaxation. For OBC- Non Creamy Layer candidates, reservation will be applicable only to those categories which are mentioned in the Central List of OBCs. Please

Percentage Eligibility:

Students securing minimum **65** % Marks/ CGPA/CPI (till declaration of last result) will only be considered. Candidates are required to specify the percentage marks in the qualifying degree. Wherever CGPA/OGPA

or letter grade in a qualifying Degree is awarded, equivalent percentage of marks should be indicated as per the norms adopted by University/Institute. Candidate will be required to submit documentary proof/certificate from the institute/University.

In case, the candidate is not able to produce the documentary proof /certificate from the Institute/University in support of the percentage marks entered, the percentage will be calculated as per the table given below:

In addition, the students should have passed in all subjects till the last result declared. However, all the candidates satisfying the minimum eligibility conditions may not be shortlisted for the interview.

The prescribed qualification/experience are the minimum and mere possession of the same does not entitle a candidate for participating in the selection process. EIL may restrict the no. of candidates to be called for interview by raising the percentage of marks obtained in qualifying examinations.
