Cut-off % : Students securing aggregate of 65% marks or more in M.E./M.Tech./M.Sc.-Engg. (till last declaration of result) as well as in B.E./B.Tech./B.Sc.(Engg.) will only be considered. Candidates are required to specify the percentage marks in the qualifying degree. Wherever CGPA/OGPA or letter grade in a qualifying Degree is awarded, equivalent percentage of marks should be indicated as per the norms adopted by University/Institute. Candidate will be required to submit documentary proof/certificate from the institute/University.

In case, the candidate is not able to produce the documentary proof /certificate from the Institute/University in support of the percentage marks entered, the percentage will be calculated as per the table given below:
